Nos termos e para os efeitos dos artigos 16^a e 17^o do Código dos Valores Mobiliários informamos que Malgorzata Ewa McGovern comunicou à Ibersol que no dia 22 de Novembro de 2019 **GOSHA HOLDINGS S.A.R.L.** passou a deter 944.856 ações da Ibersol SGPS correspondentes a 2,625% do capital, tendo ultrapassado os 2% dos direitos de voto da Ibersol SGPS.

Em 28 de Novembro de 2019, GOSHA HOLDINGS S.A.R.L. é detentora de 1.011.143 ações correspondentes a 2,809% dos direitos de voto.

São imputáveis ainda 28.268 acções, correspondentes a 0,078% dos direitos de voto, detidas por Malgorzata Ewa McGovern , conforme notificação anexa.
