Qualified Shareholding

For the purposes of Articles 16 e 17 of Portuguese Securities Code (Código de Valores Mobiliários) IBERSOL SGPS, S.A., as notification of Pedro André Gonçalves Teixeira, Pedro Barbosa Vaz Pinto de Sousa e Diogo Barbosa Vaz Pinto de Sousa, informs that on 28 July 2023 **FERGIE-Serviços e Gestão, SA** bought from **ATPS-SGPS, SA** 4,551,450 shares of Ibersol representing 10.74% of capital and voting rights.

Also informs that :

- Capital of **FERGIE- Serviços e Gestão, SA** is held 100% by **IES- Engenharia Indústria e Serviços, SGPS, SA** which in turn is owned by Pedro André Gonçalves Teixeira (50%), Pedro Barbosa Vaz Pinto de Sousa (25%) and Diogo Barbosa Vaz Pinto de Sousa (25%)

- Following this transaction, **ATPS - SGPS, SA**, which held 26,004,204 shares representing 61.39% of the capital of Ibersol SGPS, now holds 21,452,754 shares corresponding to 50.64% of the capital and voting rights

- in the circumstances foreseen in letter (e) of Article 10 of that Directive, the controlling natural person or legal entity and, provided it has a notification duty at an individual level under Article 9, under letters (a) to (d) of Article 10 of that Directive or under a combination of any of those situations, the controlled undertaking;

- in the circumstances foreseen in letter (f) of Article 10 of that Directive, the deposit taker of the shares, if he can exercise the voting rights attached to the shares deposited with him at his discretion, and the depositor of the shares allowing the deposit taker to exercise the voting rights at his discretion;
